### **REQUIREMENTS TO THE PUBLICATION:**

- **The cost of publication** depends on the volume (one page of the text completed in accordance with the below-mentioned requirements is **35 hryvnias**, plus the cost of mailing (if necessary)).

- **The volume** of a publication should not exceed *1 printer's sheet* (40 thousand characters); **page size** – A-4; **font** – *Times New Roman Cyr*; **font size** – 14; **line spacing** – 1.5; **margins**: top, bottom, right – 1.5 cm, left – 3 cm.
- The article starts with the UDC code, then, in the next line, the initials and the surname of the author are stated in bold regular letters in the top right corner. Leaving one line empty, state the publication title in capital bold letters. Leaving one line empty after the title, insert a short **indicative abstract in Ukrainian and key words**. Leaving one line empty, with an indent, start the main body of the article text. **The indent** is 10 mm.
- **References** in the text are given in square brackets (automatic references are *forbidden*), where the first number means the number in the list of references (the references list is placed at the end of the article) given in the order of appearance; after a comma and a space the page number of the quoted reference is stated (e.g., [1, 234].) and only after the closed square bracket one puts a dot (or another punctuation mark).
- All **tables** of the article are submitted as a separate file in the *Microsoft Excel* format. Based on the type of publication, we would like to ask you not to submit too many tables within the articles, and avoid tables with large size and content.
- The article **must** contain such **Parts** (specially highlighted in bold inside the text):

**Problem statement.** [Text].

**Analysis of recent research and publications.** [Text].

**Objective.** [Text].

**Exposition of the main material.** [Text].

**Conclusions.** [Text].

- At the end one presents the **Список використаної літератури** arranged in accordance with the Ukrainian standard of bibliographic description (Form 23 approved by the Order of Higher Attestation Commission of Ukraine dated 03 March 2008) and the same list arranged according to the international bibliographic standard **APA-2010 entitled as References** (See **Attachment 1**)

- After the references lists one **MUST** submit **THE EXPANDED SUMMARY OF THE ARTICLE IN ENGLISH** – the **Abstract** (see the requirements to its arrangement in **Attachment 2**).
- In a separate file, the author submits **personal details**: *surname, name, patronymic (without abbreviation), academic degree, academic title, position, establishment, home and work addresses, telephone, e-mail*.
- **For post-graduate students**: obligatory additions to the manuscript are: decisions of the corresponding chair on recommending the article for publication and a review by an expert on the research topic (Doctor or Candidate of Sciences).
- The series editorial staff preserves the right for the selection of materials for printing. **We do not consider and do not print the publications, that were not proofread (to the point of illegibility), do not meet the requirements, or were submitted after the deadline.** The article may be sent back to the author for improvements and accepted for consideration with the aim of printing it in the next edition.

## Attachment 1

### REQUIREMENTS TO THE ARRANGEMENT OF REFERENCES

The list of references has to consist of **two parts** (this requirement is also valid for the articles English):

1) **Список використаної літератури** (for articles in English: **References (in the original language)**). These references are in the original language and arranged according to the Ukrainian bibliographic description standard (Form 23 approved by the Order of Higher Attestation Commission of Ukraine dated 03 March 2008);

2) **References** – the same references, but in English, arranged in accordance with the international bibliographic standard **APA-2010** [[http://library.nmu.edu/guides/userguides/style\\_apa.htm](http://library.nmu.edu/guides/userguides/style_apa.htm)].

Titles of periodical Ukrainian and Russian publications (magazines, journals, etc.) are stated using transliteration (see [Ukrainian transliteration rules: http://zakon2.rada.gov.ua/laws/show/55-2010-%D0%BF](http://zakon2.rada.gov.ua/laws/show/55-2010-%D0%BF)), and then in English in brackets. E.g.: *Ekonomichnij Casopis-XXI (Economic Annals-XXI)*.

Titles of the references (not less than 10) in the references list are arranged in order of appearance in the text (not alphabetically). Quoting textbooks, manuals and opinion journalist articles is inappropriate.

## **English abstract to the scientific articles in the specialized journal Cherkasy University Bulletin**

**Dear contributors to the journal,**

Foreign partners and international databases set out strict requirements to the writing of **abstracts** not only in the Ukrainian journals, but also in foreign publications.

The abstract should make it clear, what the article's essence, topicality and scientific novelty are. Informational availability of the abstract will help many authors to include their articles to the index databases and will increase the citation level of the authors.

We hope that the recommendations given below will help you compile the abstract correctly.

### **Main requirements to an abstract:**

#### ***Main goals and tasks of an abstract***

An abstract is a short summary of a larger work of scientific character. **The abstract can be published independently apart from the main text, so it should be clear without reading the article itself.**

An abstract to the article is the main source of information for the local and international informational systems and databases that index the journal, as well as for the search systems.

The English abstract is placed in the English information block about the article that is loaded to the English version of the journal and is prepared for the foreign abstract databases and analytical systems (citation indexes).

Ukrainian (Russian) abstract is the basis for the English abstract, but the English abstract *has to be larger in volume and should not repeat the Ukrainian abstract*. An abstract is basically a concise exposition of the article in English, its rendering.

#### ***The structure and the content of an abstract (no less than 250 words or 1 page with the spacing of 1 pt)***

*Surname, name, patronymic, the title of the article (in English)*

- The problem – *Introduction*
- The objective – *Purpose*
- Research methods – *Methods*
- Main results of the research – *Results*
- The novelty of the research results – *Originality*.
- Conclusions and specific suggestions of the author – *Conclusion*

The methods should be described only if it has some novelty and is of interest concerning the submitted article.

The results of the work should be described in a precise and informative way. One should state the main theoretical and experimental results, factual data, revealed interrelations and regularities. The preference is given to the new results and the data of long-term importance, important discoveries, conclusions that disprove the existing theories, as well as the data that, in

the author's opinion, have a practical application. The conclusions may be accompanied by recommendations, evaluations, propositions, hypotheses described in the article.

The information given in the title of the article, *should not* be repeated in the abstract text. It is recommended to avoid unnecessary introductory phrases(e.g. "the author of the article examines..."). Historical references, unless they make up the main text of the document, the description of previously published works and commonly known provisions are not stated in an abstract.

*In the text of the abstract* one should use syntactic constructions appropriate to the scientific paper style, one should avoid complicated grammatical constructions.

It is recommended to use key words from the article text in the abstract text.

The text of the abstract should be laconic and precise, free from secondary information, unnecessary introductory words, general and non-informative wording.

Abbreviations and conventional symbols, except the ones used commonly, are used only in exceptional cases.

***The abstract must be in quality (!!!) English, and all machine (computer) translations will be returned for improvement.***
